**ORDER**

WHEREAS the institution **The Regency College of Education, No. 51/1, A.M.S. Extension, Vidyananyapura, Bangalore, Karnataka-560097** was granted recognition vide SRC (NCTE) vide order no. F.SRO/NCTE/B.Ed./2005-2006/5630 dt. 15.03.2006 for conducting B.Ed. course of one year duration with an annual intake of 100 students.

AND WHEREAS, after the promulgation of NCTE Regulations, 2014 and as per affidavits submitted by the institution on dt. 28.01.2015, the provisional revised recognition order was issued to the institution on 15.05.2015 for conducting B.Ed. course of two years' duration with an annual intake of 100 from the academic session 2015-16. The inspection of the institution was conducted on 25.11.2016 to 26.11.2016 and the VT report along with documents received on dt. 02.12.2016.

AND WHEREAS, the SRC in 381<sup>st</sup> Meeting held on 31<sup>st</sup> October & 01<sup>st</sup> November, 2019 considered the matter and decided to issue SCN in all such matters where the institution has not submitted the following requisite documents/VT Report accompanied with requisite documents in respond to RPRO issued by the SRC. Accordingly, First Show Cause Notice was issued on 08.11.2019. The institution submitted its reply on dt. 13.12.2019.

AND WHEREAS, the SRC in its 388<sup>th</sup> Meeting held on 14<sup>th</sup> & 15<sup>th</sup> September 2020 the matter was placed before the Committee and considered the matter and decided to issue Final Show Cause Notice. Accordingly, as per directed a Final Show Cause Notice was issued to the institution on dt. 23.09.2020.  
The institution submitted its reply along with documents on dt. 11.11.2020.

AND WHEREAS, the matter was considered by the SRC in its 392<sup>nd</sup> meeting held on 15<sup>th</sup>-16<sup>th</sup> December 2020 as under: -

*"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-*

**The decision of the institution be read as under: -**

*"On the perusal of the reply submitted by the institution, the Committee decided that the continuation order be issued to the Institution **The Regency College of Education, No. 51/1, A.M.S. Extension, Vidyananyapura, Bangalore, Karnataka-560097** for B.Ed programme for 2 basic units of 50 students each unit."*

NOW THEREFORE, the SRC decided to permit the institution i.e., **The Regency College of Education, Survey No.- 5/1 & 7/4-A2, No. 51/1, A.M.S. Extension, Vidyananyapura, Bangalore, Karnataka-560097** for B.Ed. course run by S.V. Educational Trust, Bangalore, Karnataka for continuation of recognition for **B.Ed. course of two years duration with an**

annual intake of 100 students (two basic units) subject to fulfilment of the following conditions:

- I. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
  - III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
7. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
  8. The institution shall submit to the Regional Committee a Self – Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
  9. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter – alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely: -
    - a. Sanctioned programme(s) along with annual intake in the institution:
    - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
    - c. Name of faculty members who left or joined during the last, quarter:
    - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
    - e. Fee charged from students.
    - f. Available infrastructural facilities.
    - g. Facilities added during the last quarter.
    - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
    - i. The affidavit with enclosure submitted along with application.
    - j. The institution shall be free to post additional relevant information, if it so desires.
    - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

10. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
11. The institution shall make available the list of students admitted on its official website.
12. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.

### ORDER

In terms of Section 14(1) of the NCTE Act, 1993 S.V. Educational Trust, Bangalore, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to The Regency College of Education, No.51/1, A.M.S. Extension, Vidyananyapura, Bangalore-560097, Karnataka for Secondary(B.Ed) Course of one year duration from the academic session 2005-06 with an annual intake of 100-students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a. The institution has acquired the land for setting up the teacher education institution.
- b. The institution has constructed the building for conducting the course on the above mentioned land.
- c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 lakhs.
- d. The institution has selected the Principal and Seven lecturers for the said course and the list of faculty members has been approved by the affiliating University.

3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to The Regency College of Education, No.51/1, A.M.S. Extension, Vidyananyapura, Bangalore-560097, Karnataka for Secondary(B.Ed) course of one year duration from the academic session 2005-2006 with an annual intake of 100 students subject to fulfillment of the following.

- a. The institution will ensure that Principal and Seven faculty members duly approved by affiliating University are in position for an intake of 100 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.



- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
  - c. The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)
  - d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like the affiliating University, UGC, State Government etc.
  5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
  6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.
